<i>MINOR SUBDIV. REVIEW FEE (under 5 lots)*</i>	<i>\$ 350.00</i>
CONDITIONAL USE Approval	\$ 800.00 Plus \$ 0.05 per square foot area of structure or the cubic yards of earth moved OR \$ 1,000.00 for Conditional Use with no structure shall be charged
<i>CONDITIONAL USE REVIEW FEE *</i>	<i>\$ 1,000.00</i>
REZONING & Zoning Ordinance Changes	\$ 1,500.00 Plus \$ 50.00 per acre
<i>REZONING &amp; ZONING ORDINANCE CHANGES REVIEW FEE *</i>	<i>\$ 1,000.00</i>
