

ORDINANCE NO. 38

AN ORDINANCE REGULATING AUTOMOBILE TRAFFIC ON WILLIAM PENN HIGHWAY BY PROHIBITING LEFT TURNS INTO WILLIAM PENN HIGHWAY, FROM THE SHOPPING CENTER PROPERTY, AND PROVIDING PENALTIES FOR VIOLATION.

The Council of the Borough of Monroeville does hereby ordain and enact the following Ordinance:

SECTION 1. That from and after the enactment of this Ordinance, it shall be unlawful for any vehicle, automobile or otherwise, at any time, to be driven or moved into or onto the William Penn Highway, Route No. 22, from the property of the Miracle Mile Shopping Center, by making a left or westerly turn from said Shopping Center property into said Highway. Provided, and excepting however, emergencies as hereinafter provided, as may occur.

SECTION 2. Such left turns by traffic, as hereinbefore set forth, are hereby prohibited, except in cases of emergency, when, under the direction, authority and supervision of proper police officials, such traffic movement shall be permissible. The Borough Police Department and/or the Burgess are hereby delegated with authority and discretion in determining such emergencies. Such emergencies shall be of a temporary nature and for a temporary period as shall be directed and upon the termination of which emergency, the status of traffic conditions shall revert back to status quo and regulations of this Ordinance.

SECTION 3. The Borough Police Department is hereby authorized and directed to have prepared proper signs, of reasonable size, and post the same in proper position and location so as to give ample warning and notice to motorists and public, of this Ordinance.

SECTION 4. Any person or persons operating, driving or moving any vehicle, automobile or otherwise, as hereinbefore set forth, in violation of the provisions of this Ordinance, shall be subject to arrest and prosecution, as in summary conviction proceedings, before the Burgess or any Justice of the Peace of the Borough and upon conviction shall be subject to a fine of \$10.00, together

with costs of prosecution in each instance, and in default or failure to pay same, shall be subjected to serve not more than thirty (30) days incarceration in the Allegheny County Jail.

SECTION 5. Any Ordinance or part of an Ordinance which shall be inconsistent with the provisions of this Ordinance are hereby repealed insofar as the same are inconsistent or contradictory with the provisions of this Ordinance.
