

ORDINANCE No. 139

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, PROHIBITING THE USE OF FIREARMS AIR GUNS OR SPRING GUNS WITHIN CERTAIN LIMITS IN SAID BOROUGH AND REGULATING THE SALE OF AIR GUNS, SPRING GUNS AND RIFLES EXCEPT BY LICENSED DEALERS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ORDAINED AND ENACTED By the Council of the Borough of Monroeville, and it is hereby ordained and enacted by the authority of the same;

Section 1. That from and after the passage of this Ordinance, the use or discharge on the streets, alleys, parks and other public places, or within a distance of five hundred (500) feet from any residence or building within the limits of the Borough of Monroeville, of any rifle shotgun, revolver, pistol, flobert rifle, air gun, spring gun or other implement which impels with force a pellet of any kind, is prohibited.

Section 2. The use or discharge of any blank cartridge in any rifle, shotgun, revolver, pistol, flobert rifle or any similar firearm in the streets, alleys, parks or other public places within the limits of the Borough of Monroeville, is prohibited.

Section 3. No person, firm or corporation shall sell or offer for sale any air gun, spring gun or flobert rifle, unless he, they or it shall have first received a written license so to do signed by the Borough Secretary, which license shall be issued only upon payment of an annual license fee of ten (\$10.00) Dollars to expire at the end of one year from date thereof unless renewed upon due application and payment of a like amount for each year thereafter.

Section 4. This Ordinance shall not apply to any owner or lessor of property in the Borough of Monroeville discharging firearms in the destruction of predatory animals, nor to any bona fide and duly organized gun or sportsman's club.

Section 5. Any person violating any provisions of this Ordinance shall, upon conviction there of before the Burgess or any Justice of the Peace, be sentenced to pay a fine of not less than Ten (\$10.00) Dollars, and for second offense, not less than Twenty-five (\$25.00) Dollars, nor more than One Hundred (\$100.00) Dollars, and in default of payment thereof, shall be sentenced to undergo imprisonment in the Allegheny County jail for a period of not less than ten (10) days, nor more than thirty (30) days.

Section 6. Each and every violation shall be considered as a distinct and separate offense.

Section 7. All ordinances or parts of such conflict.
