

ORDINANCE NUMBER 166

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA ADOPTING AMENDMENTS TO THE ARTICLES OF INCORPORATION OF PATTON TOWNSHIP MUNICIPAL AUTHORITY.

WHEREAS, the Borough of Monroeville (formerly the Township of Patton) has heretofore created Patton Township Municipal Authority under the provisions of the Municipality Authorities Act of 1945, as amended; and

WHEREAS, Patton Township Municipal Authority has submitted to the Council of the Borough of Monroeville a resolution amending the Articles of Incorporation of Patton Township Municipal Authority:

NOW THEREFORE BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville, and it is hereby ordained and enacted by the authority of the same as follows:

Section 1. The Borough of Monroeville hereby adopts the following amendments to the Articles of Incorporation of Patton Township Municipal Authority, which amendments shall consist of the following:

(a) amending paragraph First of said Articles of Incorporation to read in full as follows

"First: The name of the Authority shall be: 'Monroeville Water Authority'."

(b) amending said Articles of Incorporation by adding a new provision thereto, which new provision shall read as follows:

"Sixth: The term of existence of the Authority is increased to a date fifty (50) years from the date of approval of these Articles of Amendment."

Section 2. All ordinances or parts of ordinances not in accord with this Ordinance are hereby repealed and rescinded insofar as they conflict herewith.
