NOTICE OF INTENTION TO ADOPT AN ORDINANCE FOR THE BUILDING OF THE SOUTH PITCAIRN SANITARY SEWER.

NOTICE OF INTENTION IS HEREBY GIVEN BY THE BOROUGH OF MONROEVILLE TO ADOPT AN ORDINANCE AT ITS REGULAR MEETING ON SEPTEMBER 13, 1960, AT 8:00 P.M. IN THE MUNICIPAL BUILDING, MONROEVILLE, PENNSYLVANIA, AUTHORIZING THE CONSTRUCTION OF THE SOUTH PITCAIRN SANITARY SEWER. THE ORDINANCE WILL BE IN SUBSTANTIALLY THE FOLLOWING FORM:

ORDINANCE NO. 218

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE CONSTRUCTION OF A SANITARY SEWER IN SEWER AREA "E" IN ACCORDANCE WITH AND AS SHOWN ON CONTRACT NO. 4 S OF PRIDE ENGINEERING ASSOCIATES, PROVIDING FOR THE COST OF THE CONSTRUCTION THEREOF, THE PAYMENT OF DAMAGES TO PRIVATE PROPERTY AND THE METHOD OF COLLECTING THE SAME.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville, County of Allegheny and Commonwealth of Pennsylvania; and it is hereby ordained and enacted by and with the authority of the same.

SECTION 1. That a sanitary sewer be constructed in sewer area "E", in accordance with and as shown on Contract No. 4 S, of Pride Engineering Associates, through the land of Pitcairn Borough, Allegheny County, Pennsylvania.

SECTION 2. That said sewer shall be constructed in accordance with the plans and specifications prepared by the Borough Engineer which said plans are on file in the office of the Borough Manager, Municipal Building, Monroeville, Pennsylvania.

SECTION 3. That the costs, damages and expenses for the construction of said sewer shall be collected from the properties specifically benefited along the line of said sewer in the manner as now prescribed by law.

SECTION 4. That any Ordinance or part of Ordinance conflicting with the terms of this Ordinance be and the same is hereby repealed.
