

BOROUGH OF MONROEVILLE  
ORDINANCE NO. 253

AN ORDINANCE VACATING ACCESS ROAD, IN THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, WHICH LIES BETWEEN THE NEW U. S. ROUTE #22 AND THE OLD US ROUTE #22, WHICH IS SOMETIME KNOWN AS MC CLURE ROAD.

SECTION 1. The Borough of Monroeville hereby ordains as follows:

ALL that piece of ground which lies between the new U. S. Route #22 and the old U. S. Route #22, which piece of ground is named Access Road and sometimes called McClure Road, in the Borough of Monroeville, Allegheny County, Pennsylvania, being bounded and described as follows, to-wit:

BEGINNING at a point on the northerly right of way line of new U. S. Route #22, at or near Station No. 499.60; thence along said right of way line in a westerly direction by the arc of a circle curving to the left and having a radius of 1308.07 feet, an arc distance of 151.16 feet to a point; thence along the northwesterly corner of new U. S. Route #22 and the Access Road in a northeasterly direction by the arc of a circle curving to the left and having a radius of 50 feet, an arc distance of 69.20 feet to a point; thence along the westerly side of the Access Road, North 26° 00' 50" East, 81.50 feet to a point; thence along the southwesterly corner of old U. S. Route #22 and said Access Road in a northwesterly direction by the arc of a circle curving to the left and having a radius of 50 feet, an arc distance of 82.61 feet to a point on the southerly right of way line of old U. S. Route #22; thence along said southerly right of way line of old U. S. Route #22, South 68° 39' 10" East, 78.25 feet to a point; thence still along the same, South 54° 26' 10" East 85.55 feet to a point; thence along the southeasterly corner of old U. S. Route #22 and said Access Road in a southwesterly direction by the arc of a circle curving to the left and having a radius of 50 feet, an arc distance of 86.87 feet to a point; thence along the easterly right of way line of the Access Road, South 26° 00' 50" East, 55 feet to a point; thence along the northeasterly corner of new U. S. Route #22 and said Access Road in a southeasterly direction by the arc of a circle curving to the left and having a radius of 50 feet, an arc distance of 81.76 feet to a point in the northerly right of way line of new U. S. Route #22 at the place of beginning, be and the same is hereby vacated.

SECTION 2. Any Ordinance or part of an Ordinance conflicting with the terms of this Ordinance is hereby repealed to the extent of such conflict.
