ORDINANCE NO. 260

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE CONSTRUCTION OF A SANITARY SEWER IN SEWER AREA "E" IN ACCORDANCE WITH AND AS SHOWN ON CONTRACT NO. 4 S, OPTIONS I AND II OF PRIDE ENGINEERING ASSOCIATES, PROVIDING FOR THE COST OF THE CONSTRUCTION THEREOF, THE PAYMENT OF DAMAGES TO PRIVATE PROPERTY AND THE METHOD OF COLLECTING THE SAME.

Be it ordained and enacted by the Council of the Borough of Monroeville, County of Allegheny and Commonwealth of Pennsylvania; and it is hereby ordained and enacted by and with the authority of the same.

SECTION 1. That a sanitary sewer be constructed in sewer area "E", in accordance with and as shown on Contract No. 4 S, Options I and II of Pride Engineering Associates, as indicated therein.

SECTION 2. That said sewer shall be constructed in accordance with the plans and specifications prepared by the Borough Engineer which said plans are on file in the office of the Borough Manager, Municipal Building, Monroeville, Pennsylvania, through the properties of:

ORDINANCE NO. 260 - 3
