

ORDINANCE NO. 300

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE PROVIDING FOR THE EXECUTION OF A CONTRACT NO. 9-S, BY AND BETWEEN THE BOROUGH OF MONROEVILLE AND TORO DEVELOPMENT CO.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, and it is hereby ordained and enacted by the authority of the same.

SECTION 1. Upon the opening of bids for the building of North Pitcairn Sanitary Sewer Extension, Contract No. 9-S, of the Borough of Monroeville, it appears that the lowest responsible bidder is Toro Development Co., whose gross sum bid is Forty Seven Thousand Four Hundred Sixteen and 20/100 (\$47,416.20) Dollars.

SECTION 2. It also appears that the Borough shall by Agreement with Alphonso Monzo and others upon completion of said 9-S sewer line receive as liquidated net benefits the sum of Twenty Five Thousand and no/100 (\$25,000.00) Dollars for the service that this sewer line shall provide to property of the said Alphonso Monzo, et al.

SECTION 3. It also appears to the Borough that the assessments for benefits that the said 9-S sewer line will provide will be sufficient to pay for the cost of construction of the same, together with all incidental and attending costs.

SECTION 4. Upon and after execution of the contract with Alphonso Monzo, et al., which the Borough has approved through Ordinance No. 297, the proper officers of the Borough are hereby authorized and directed to enter into a contract with Toro Development Co., being Contract No. 9-S, according to the plans and specifications therefor as established by Pride Engineering Associates, Inc., consulting engineers for the Borough of Monroeville, for the gross sum of Forty Seven Thousand Four Hundred Sixteen and 20/100 (\$47,416.20) Dollars.

SECTION 5. For the execution of said contract, the said contractor, Toro Development Co., shall have filed with the Borough Secretary a performance bond in the amount of Forty Seven Thousand Four Hundred Sixteen and 20/100 (\$47,416.20) Dollars, a labor and materialmen's bond in the amount of Forty Seven Thousand Four Hundred Sixteen and 20/100 (\$47,416.20) Dollars, and certificates of insurance covering personal injury and property damage and workmen's compensation liability, all as set forth and required under said Contract No. 9-S.

SECTION 6. Any Ordinance or part of any Ordinance that shall conflict with this Ordinance is hereby repealed to the extent of such conflict.
