

ORDINANCE NO. 344

AN ORDINANCE AMENDING ORDINANCE NO. 1 KNOWN AS THE OFFICIAL ZONING ORDINANCE OF THE BOROUGH OF MONROEVILLE, BY CHANGING THE CLASSIFICATION OF CERTAIN PROPERTY PRESENTLY OWNED BY RUSSELL P. MILLER, INC. FROM RESIDENTIAL R-1 TO MANUFACTURING AND LIGHT INDUSTRIAL M.L.I. -1.

SECTION 1. Be it ordained and enacted the Council of the Borough of Monroeville, Allegheny County, Pennsylvania, and it is hereby ordained and enacted by the authority of same:

That Ordinance No. 1 known as the OFFICIAL ZONING ORDINANCE of the Borough of Monroeville be amended and revised in the manner following:

SECTION 2. That the property of RUSSELL P. MILLER, INC. described below and presently zoned Residential R-1 be reclassified and rezoned to Manufacturing and Light Industrial M. L. I. -1.

ALL that certain lot or piece of ground situate in the Borough of Monroeville, County of Allegheny and Commonwealth of Pennsylvania, being bounded and described as follows, to-wit:

BEGINNING at a point on the Easterly line of Bethel Road at the line of land of Russell P. Miller, Inc. thence along the line of land of Russell P. Miller, Inc., South $89^{\circ} 35'$ East, 300 feet to a point; thence continuing by the same, South $0^{\circ} 25'$ West, 436.91 feet to a point on the line of land now or late of S. Cunningham; thence along the line of land now or late of S. Cunningham, North $49^{\circ} 39'$ West, 415.79 feet to a point on the Easterly line of Bethel Road; thence along the Easterly line of Bethel Road, Northwardly by the arc of a circle curving to the left with a radius of 150 feet, an arc distance of 76 feet to a point; thence continuing by the Easterly line of Bethel Road, North $0^{\circ} 25'$ East, 97.24 feet to the point, at the place of beginning.

SECTION 3. That Section 7 of Article III of said Ordinance No. 1 be amended by adding to the list of Manufacturing and Light Industrial M. L. I. -1, property of RUSSELL P. MILLER, INC. as described in Section 2 above and that pursuant thereto, the official zoning map accompanying Ordinance No. 1 be amended by changing the designation of the above-described area from Residential R-1 to Manufacturing and Light Industrial M. L. I. -1.

SECTION 4. That any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance be and the same is hereby repealed to the extent of such conflict.
