

ORDINANCE NO. 425

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING AND DIRECTING THE CONSTRUCTION OF A SANITARY SEWER IN ACCORDANCE WITH PLANS AND SPECIFICATIONS PREPARED BY THE BOROUGH OF MONROEVILLE, KNOWN AS CONTRACT NO. 6313-S, AND PROVIDING FOR THE EXECUTION OF A CONTRACT FOR THE CONSTRUCTION THEREOF AND PROVIDING FOR THE COST OF CONSTRUCTION.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, and it is hereby ordained and enacted by authority of the same.

SECTION 1. That a trunk line sanitary sewer be constructed by the Borough of Monroeville to connect an area generally known as McKinney Heights Plans 1 and 2, lying wholly within the Borough of Monroeville, with the existing sanitary sewer system of the Borough, all in accordance with the plans and specifications of the Borough of Monroeville known as McKinney Heights Sanitary Sewer Contract No. 6313-S.

SECTION 2. That the said sewer line shall be constructed in accordance with the plans and specifications as prepared by the Borough Engineer, which plans are on file in the office of the Borough engineer, Municipal Building, Monroeville, Pennsylvania.

SECTION 3. Upon the opening of bids for the building of said sewer project Contract No. 6313-S, it appeared that the lowest responsible bidder for the construction thereof was Dana Construction Company, whose gross sum bid was Seven Thousand Two Hundred Ninety-six and 50/100 (\$7,296.50) Dollars.

SECTION 4. The proper officers of the Borough of Monroeville are hereby authorized and directed to enter into a contract with Dana Construction Company for the construction of the said sewer project Contract No. 6313-S according to the plans, specifications, conditions and agreements therein contained, as established and approved by the Borough Engineer of the Borough of Monroeville, for the gross sum of Seven Thousand Two Hundred Ninety-six and 50/100 (\$7,296.50) Dollars.

SECTION 5. Upon execution of the Contract, the said contractor shall file with the Borough Secretary a performance bond and a labor materialmen's bond, each equal to ONE HUNDRED (100%) PERCENT of the gross sum bid, maintenance bond in an amount equal to FIFTEEN (15%) PERCENT of the gross sum bid, and certificates of insurance covering personal injury, property damage and workmen's compensation and liability, all set forth and required under said Contract No. 6313-S.

SECTION 6. That the costs, damages and expenses for the construction of the said sewer line shall be collected from the property owners specially benefited thereby in the manner as now prescribed or as may be hereafter prescribed by law.

SECTION 7. Any Ordinance or part of any Ordinance that shall conflict with this Ordinance is hereby repealed to the extent of such conflict.
