

ORDINANCE NO. 457

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING AND DIRECTING THE CONSTRUCTION OF CERTAIN SANITARY SEWER EXTENSIONS, KNOWN AS WILLIAMSBURG HEIGHTS CONTRACT PROJECT NO. 6404-S, AND PROVIDING FOR THE EXECUTION OF A CONTRACT THEREFOR.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, as follows:

SECTION 1. That the following sanitary sewer line extensions and attendant facilities be constructed by the Borough of Monroeville to be incorporated as part of the Borough of Monroeville sanitary sewer system, in accordance with plans and specifications therefor known as "Williamsburg Heights Project Contract No. 6404-S":

- (a) Williamsburg Heights - approximately nine hundred (900) lineal feet more or less.
- (b) Haymaker Road - approximately one hundred (100) lineal feet more or less.
- (c) Beatty Road - approximately two hundred (200) lineal feet more or less.
- (d) Kenmar Drive - approximately one hundred fifty (150) lineal feet more or less.
- (e) 1. Elmwood Street - approximately six hundred fifty (650) lineal feet more or less.
- (e) 2. Brinton Street - approximately five hundred (500) lineal feet more or less.
- (f) Cathedral Drive - approximately two hundred fifty (250) lineal feet more or less.
- (g) Medici Plan - approximately five hundred ten (510) lineal feet more or less.
- (h) Princeton Road - approximately five hundred fifty (550) lineal feet more or less.
- (i) James Street - approximately seven hundred (700) lineal feet more or less.

SECTION 2. That the said sanitary sewer line extensions be constructed in accordance with the plans and specifications as prepared by the Monroeville Borough Engineer, which are on file in the office of the Borough Engineer, Municipal Building, Monroeville, Pennsylvania.

SECTION 3. Upon the opening of bids for the building of the said sewer projects, designated as Contract No. 6404-S, it appeared that the lowest responsible bidder for the construction thereof was Dana Construction, Inc., whose gross sum bid was Twenty-seven thousand nine hundred sixty-five (\$27,965.00) Dollars.

SECTION 4. The proper officers of the Borough of Monroeville are hereby authorized and directed to enter into a contract with the said Dana Construction, Inc. for the construction of the said sanitary sewer project Contract No. 6404-S, according to the plans, specifications, conditions and agreements therein contained, as established and approved by the Monroeville Borough Engineer, for the gross sum of Twenty-seven thousand nine hundred sixty-five (\$27,965.00) Dollars.

SECTION 5. Upon the execution of said contract the said contractor shall file with the Borough Manager the performance bond, labor and material-men's bond, maintenance bond and certificates of insurance, as required under the terms of said contract.

SECTION 6. Item 8 of Section 1 of Ordinance No. 431 of the Borough of Monroeville, enacted April 16, 1964, wherein certain sewer projects were authorized to be constructed by the Monroeville Water Authority, said item 8 reading "Princeton Road Project Contract No. 6404-S", shall be and the same is hereby deleted therefrom, and the Borough Manager is directed to so notify the Monroeville Water Authority forthwith.

SECTION 7. Any ordinance or parts of ordinances in conflict with any of the provisions of this Ordinance are hereby repealed to the extent of such conflict.
