

ORDINANCE NO. 460

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE ACCEPTING THE DEDICATION OF CERTAIN PARCELS OF LAND FOR THE PURPOSE OF LAYING OUT A MUNICIPAL ROAD KNOWN AS "JOHN STREET".

WHEREAS Louis D. Karish, Jr. and Rose Marie Karish, his wife, Frank J. Pugliano and Phyllis D. Pugliano, his wife, John DiTommaso, also known as Giovanni DiTommaso, and Sarah DiTommaso, his wife, Sisto Rossetti and Helen Rossetti, his wife, Edmond Rossetti and Josephine C. Rossetti, his wife, Albert Pugliano and Dorothy Pugliano, his wife, Donald D. Mignogna and Mary P. Mignogna, his wife, Bernard J. Orpel and Mary E. Orpel, his wife, Carmen R. Biondo and Mary E. Biondo, his wife, Fred Hayton and Mildred Hayton, his wife, and Assunta Rossetti, all owners of property in the Borough of Monroeville, Allegheny County, Pennsylvania, by their deeds of dedication, duly executed, acknowledged and delivered to the Borough of Monroeville, have conveyed certain parcels of land therein described to the Borough for road, utility and other municipal purposes; and

WHEREAS the combined grants of property make available to the Borough of Monroeville sufficient area for the purpose of constructing and maintaining a municipal street therein and thereon;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, as follows:

Section 1. The deeds of dedication to the Borough of Monroeville from Louis D. Karish, Jr. and Rose Marie Karish, his wife dated October 15, 1964, Frank J. Pugliano and Phyllis D. Pugliano, his wife, dated October 15, 1964, John DiTommaso, also known as Giovanni DiTommaso, and Sarah DiTommaso, his wife, dated October 15, 1964, Sisto Rossetti and Helen Rossetti, his wife, dated October 15, 1964, Edmond Rossetti and Josephine C. Rossetti, his wife, dated October 15, 1964, Albert Pugliano and Dorothy Pugliano, his wife, dated October 15, 1964, Donald D. Mignogna and Mary P. Mignogna, his wife, dated October 15, 1964, Bernard J. Orpel and Mary E. Orpel, his wife, dated October 30, 1964, Carmen R. Biondo and Mary E. Biondo, his wife, dated October 15, 1964, Fred Hayton and Mildred Hayton, his wife, dated October 30, 1964, and Assunta Rossetti, dated October 15, 1964, are hereby accepted by the Borough of Monroeville for the purposes therein contained.

Section 2. The combined parcels of land described in said deeds of dedication, forming a continuous strip of land not less than thirty-three (33) feet in width according to a survey of the same made for the Borough of Monroeville by Thompson Survey Service (Survey No. E-1203), shall be incorporated as part of the municipal road system of the Borough of Monroeville and shall hereafter be known and designated as "John Street".

Section 3. Any ordinance or part of ordinance in conflict with any of the provisions of this ordinance is hereby repealed to the extent of such conflict.
