

ORDINANCE NO. 552

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING THE CONSTRUCTION OF CERTAIN MISCELLANEOUS SANITARY SEWER PROJECTS, KNOWN AS CONTRACT NO. 6608-S, AND PROVIDING FOR THE EXECUTION OF SUCH CONTRACT.

BE IT ORDAINED by the Borough of Monroeville as follows:

Section 1. Certain miscellaneous sanitary sewer lines shall be constructed in various sections of the Borough, according to the plan therefor known as the Borough of Monroeville Sanitary Sewer Contract No. 6608-S, as follows:

- (1) Along Moss Side Boulevard and property of Edward McCrady, Jr.
- (2) Along the southerly side of Northern Pike west of Moss Side Boulevard.
- (3) Along the northerly side of Northern Pike west of Penn View Drive.
- (4) A stub across Pitcairn Road.
- (5) Along the east side of Moss Side Boulevard south of Northern Pike.
- (6) Along the north side of Northern Pike and connecting to the La Vale Plan of Lots.
- (7) From the southerly side of the La Vale Plan of Lots to the Turnpike trunk line sewer.
- (8) In the vicinity of Kelvington Drive and Brett Drive.
- (9) A connecting spur from the Cherry Hills Plan into the Green Hills Plan.
- (10) Along Saunders Station Road near Red Gate Drive.

Section 2. Upon the opening of bids for the building of said sewer projects, it appeared that the lowest responsible bidder there-

for was Frank Rizzi, Inc., whose total bid, based on quantities contained in said contract, was Thirty-seven Thousand Eight Hundred Seven and 50/100 (\$37,807.50) Dollars.

Section 3. The proper officers of the Borough of Monroeville are hereby authorized and directed to enter into a contract with Frank Rizzi, Inc. for the construction of the said Contract No. 6608-S for the said sum of Thirty-seven Thousand Eight Hundred Seven and 50/100 (\$37,807.50) Dollars. Upon the execution of the said contract said contractor shall file with the Monroeville Borough Manager a performance bond, labor and materialmen's bond, maintenance bond and certificates of insurance, as required in said contract.
