

ORDINANCE NO. 650

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE LAYING OUT, OPENING, WIDENING AND RECONSTRUCTING PORTIONS OF SPEELMAN LANE, ESTABLISHING A NEW GRADE THEREFOR, AND PROVIDING FOR THE EXECUTION OF A CONSTRUCTION CONTRACT.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, as follows:

Section 1. The right-of-way limits of Speelman Lane shall be widened as shown on the Right-of-Way Plan for the same dated July, 1968, revised July 16, 1968, as prepared by S. E. Michael, Registered Engineer, and under the supervision of the Monroeville Borough Engineer, extending from Monroeville-Turtle Creek Road northwardly to James Street.

Section 2. The new grade of the said Speelman Lane is hereby established as the grade as shown on the Construction Plan of the Borough of Monroeville designated Contract No. 69 R 4.

Section 3. The said Construction Plan of Speelman Lane shall be on file at the office of the Monroeville Borough Engineer and shall be made available for inspection by any interested person during regular business hours.

Section 4. The said Construction Plan is hereby adopted as the official street plan of Speelman Lane as shown thereon.

Section 5. Upon the opening of competitive bids for the said widening and reconstruction of Speelman Lane it appeared that the lowest responsible bidder therefor was Lampl Asphalt Paving Company, Inc., whose bid, based on estimated quantities set forth in said Contract No. 69 R 4, was Ninety-six Thousand Nine Hundred Thirty and 50/100 (\$96,930.50) Dollars, plus an additional sum of Nine Hundred Ninety-five (\$995.00) Dollars for Alternate No. 1 in said Contract. The President of Council and Secretary are accordingly authorized to enter into a contract with Lampl Asphalt Paving Company, Inc. on behalf of the Borough for the work to be done under the said Contract No. 69 R 4, together with Alternate No. 1, according to the terms of the bid as submitted.

Section 6. This Ordinance shall become effective thirty (30) days from the date of enactment hereof.

Section 7. Any ordinance or part of ordinance in conflict with any of the provisions of this Ordinance is hereby repealed to the extent of such conflict.
