ORDINANCE NO. 886

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE EXECUTION AND DELIVERY OF A JOINT COOPERATION AGREEMENT WITH THE GATEWAY SCHOOL DISTRICT PROVIDING FOR THE PAVING AND/OR REPAVING OF SPECIFIED AREAS ON PROPERTY OF GATEWAY SCHOOL DISTRICT.

The Council of the Borough of Monroeville ordains and enacts as follows:

Section 1. Pursuant to authority granted the Act of July 12, 1972, No. 180, the "Intergovernmental Cooperation Act, the proper officers of the Borough are hereby authorized and directed to execute and deliver an Intergovernmental Cooperation Agreement with the Gateway School District in the form attached hereto as Annex A.

JOINT COOPERATIVE AGREEMENT  
Pursuant to the Act of July 12, 1972  
No. 180 (53 P. S. Sec. 1801-901-902)

BETWEEN

THE BOROUGH OF HONROEVILLE, a municipal corporation of the Commonwealth of Pennsylvania, hereinafter called "Borough"

GATEWAY SCHOOL DISTRICT, a School District of the Second Class created and existing under the laws of the Commonwealth of Pennsylvania, hereinafter called "Gateway"

WITNESSETH:

WHEREAS, the "Intergovernmental Cooperation Act", No. 180 of July 12, 1972, authorizes joint cooperation between two or more municipalities in the exercise or in the performance of their respective governmental functions, powers or responsibilities; and

WHEREAS, on May 14, 1974, the Borough after proper advertisement for bids, awarded a contract for road paving materials, miscellaneous paving, pipe supplies, slag, equipment rental, sign posts and guard fence to Burrell Construction and Supply Company and Maurice Construction and Paving Corporation; and

WHEREAS, Gateway is desirous of paving and/or repairing specified areas on Gateway properties and the Borough has consented to perform or cause to be performed such paving and/or repairing under the aforesaid contracts.

NOW, THEREFORE, intending to be legally bound hereby the parties hereto agree as follows:

1. Borough shall perform or cause to be performed the paving and/or

repairs in accordance with Schedule "A" which is attached hereto and made a part hereof.

2. All work to be performed under this Agreement shall be completed no later than September 1, 1974, unless a later date is mutually agreed upon in writing by the parties hereto.

3. Borough shall bill Gateway on a per ton basis for paving and on a per square yard basis for sealing. Such billing shall include Contractor verification of tonnage and square yards to substantiate payments in accordance with the terms and conditions of the awarded bids.

4. Gateway shall promptly pay to Borough from current budgeted revenues the amounts of bills rendered to Gateway by Borough in accordance with the provisions of Paragraph No. 3 above.

5. Pursuant to Section 8 of Act No. 180 of 1972, this Agreement has been submitted to the Local Government Commission for review and recommendation.

6. This Agreement has been approved by Resolution of Gateway which Resolution was approved July 30, 1974, as evidenced by the signature of the President of its Board of School Directors and its Secretary, and has been approved by the Borough of Ordinance No. 886 adopted August 13, 1974.
