ORDINANCE NO. 891

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING THE APPROPRIATE OFFICIALS OF THE BOROUGH OF MONROEVILLE TO ENTER INTO AN AGREEMENT WITH THE SENIOR CITIZENS CLUB OF THE BOROUGH OF MONROEVILLE FOR THE PURCHASE OF A BUS TO BE USED BY THE SENIOR CITIZENS OF THE BOROUGH OF MONROEVILLE AND THE HANDICAPPED OF THE BOROUGH OF MONROEVILLE

BE IT ORDAINED and enacted by the Borough of Monroeville, in Council assembled, as follows:

<u>Section 1.</u> That the Borough of Monroeville is hereby authorized to advertise and receive bids for the purchase of a special use bus to be used for transportation by the senior citizens of the Borough of Monroeville and the handicapped of the Borough of Monroeville.

Section 2. That the Borough of Monroeville is hereby authorized to award a contract to the lowest responsible bidder for the purchase of said special use bus and the appropriate officials of the Borough of Monroeville are authorized to enter into an agreement with the Senior Citizens Club of the Borough of Monroeville which shall delineate the responsibility for said bus with respect to ownership and operation. A copy of said contract is attached hereto and marked Exhibit "A".

EXHIBIT "A"

AGREEMENT

THIS AGREEMENT made this 12th day of November, 1974, is by and between the BOROUGH OF MONROEVILLE (hereinafter referred to as "Borough") and the SENIOR CITIZENS CLUB OF MONROEVILLE (hereinafter referred to as "Club").

WITNESSETH:

WHEREAS, the Borough is desirous of purchasing a bus for use by senior citizens and the handicapped of the Borough of Monroeville.

WHEREAS, provisions have been made for the funding of said purchase.

WHEREAS, the Club is desirous of having the Borough purchase said bus for use by the Club and the handicapped of the Borough of Monroeville.

NOW, THEREFORE, in consideration of the above and in consideration of the foregoing and intending to be legally bound hereby, the parties hereto agree as follows:

- 1. The Borough hereby agrees to advertise for public bids to obtain the lowest possible purchase price for said bus, to award the bid to the lowest responsible bidder and to assume all reasonable responsibilities with respect to the ownership and operation of the said bus, including but not necessarily limited to, the purchase of adequate liability and comprehensive policy, maintenance, petroleum products and various necessary and reasonable repair work.
- 2. The Club agrees to pay to the Borough for the purchase of said bus, an amount equal to the sum of the grant received by the Club from the Pittsburgh Foundation, plus all interest earned on that amount from the time of the grant until delivery of the bus to the Borough.
- 3. The Borough agrees to pay the difference between the amount submitted by the lowest responsible bidder (purchase price) and the total amount paid by the senior citizens to the Borough, provided however, that said amount does not exceed any allowable limit by applicable law.
- 4. The Club shall assume responsibility for scheduling and operating the bus, the use of which shall be primarily for transportation for the senior citizens of the Borough of Monroeville and for the handicapped of the Borough of Monroeville.
